The meeting was called to order by Cindy Larsen at 5:33 p.m.

#### I. Introductions

The Chair called for introductions.

### II. Correspondence

No correspondence presented at the meeting.

#### III. Minutes

Trustee Thorson moved to approve the minutes of the December 19, 2022, Regular Board Meeting. Trustee Wilondek seconded the motion. The motion passed unanimously.

- President's Update: President Villmer reviewed his report. In addition to his report,
  President Villmer stated a personnel update on the Women's Basketball program at DCC.
  He also thanked all of the faculty, staff and the coaches for being so student-focused
  during this process.
- **Department Reports:** Department reports are in the packet for review. Dean of Academics, Matt Hull, shared an update on the Second Chance Pell Grant. They currently have their first set of 10 students that are in the Montana Women's Prison in Billings, MT. Erin Kaufman has taken on the coordinator role on this project and has been working alongside financial aid and student services.
