Dawson Community College Board of Trustees Minutes of the Regular Board Meeting Monday, December 16, 2024, at 5:30 pm Recorded by Daisy Nyberg

Chair Larsen called the meeting to order at 5:30 p.m.

I. Introductions

Chair Larsen called for introductions. Introductions were made around the room.

II. Correspondence

III. Minutes

Trustee Johnson moved and Trustee Thorson seconded to approve the minutes from November 25, 2024, regular board meeting with the corrections from Nick Staffileno.

IV. Reports

• President's Update:

President Knudson reviewed the college overall. The Audit for FY22 is completed and is reasonably good and fairly clean. We had finals through last Thursday and students who are on probation or suspension were sent letters. We had 11 students on probation and 1 student is suspended. We had 78 students on the Dean's list with 38 being Presidential Honors, 28 High Honors, and 19 Honors. The winter session started today with 54 students taking 75 classes and must be paid by 5 pm tomorrow night. We hired a new baseball coach who started today (12/16/2024). President Knudson is monitoring the lead up to legislative session and OCHE did their first presentation of the governor's budget today. On Wednesday, President Knudson and Gina Roos will attend the Second Chance Pell Graduation. When this cohort will end, DCC will not pursue this program further due to the various negative financial aspects of this program.

• Department Reports:

Reports were included in the packet for review.

Director Miller, Dean Nyberg, Director Harp, Dean Smith, and Director Peterson reviewed each departments' report included in the board packet. Director Harp also discussed he had received \$8,200 in unrestricted funds today and they are hoping their scholarship drive that ends on December 31, 2024, will be a tremendous success. Discussion from the board regarding the increase in scholarships given this year led to the acknowledgment that a marketing campaign this past spring was successful and as further endowment monies become available DCC will be seeking to improve the scholarship process.

• Finance Committee

Dean Smith gave a thorough review of the AY 22 audit and the findings. She also discussed the improvement in the amount of bad debt by her department instituting a payment plan this fall.

Chairperson Larsen asked the board to review the vouchers in the packet.

A copy of the voucher list was included in the board packet for review.

Human Resource Committee

No meeting was held in December. New Head Baseball coach hired 12/16/2024.

The updated Human Resource report was included in the board packet for review.

Policy Committee

The board discussed moving the December 2025 meeting from Monday Dec. 22, but opted to leave it on Dec. 22 at this time. The motion passed unanimously.
