Dawson Community College Board of Trustees Minutes of the Regular Board Meeting Monday, November 27, 2023 5:30 pm Recorded by Becca Klang

Chair Cindy Larsen called the meeting to order at 5:35 p.m.

I. Introductions

Chair Larsen called for introductions. Introductions were made around the room.

II. Correspondence

A few emails were included in the Board packet. One was from Maria Nash regarding a non-DCC issue and one from Previous Criminal Justice Faculty, Robert Buescher.

III. Minutes

Trustee Heidner moved to approve the minutes of the October 23, 2023, Regular Board Meeting. Trustee Garceau-Glaser seconded the motion. The motion passed unanimously.

IV. Reports

• President's Update:

President Villmer's president's update was hand delivered to the meeting. He highlighted a few items in the report. One item he covered was the Montana Campus Compact Award. One of our students, Lauren Rodacker was selected for our school and was presented her award at the Brawl of the Wild game in Missoula, MT. President Villmer also talked about the Native Voices Art Exhibition in the Library and the Fall student concert that have occurred on campus. The United Stated Department of Education has recognized Dawson Community College ranked as sixth highest transferout rate in Montana for Title IV students. President Villmer also spoke on a few upcoming events such as the HiSet Graduation ceremony occurring December 1, 2023 and the Dawson Community College holiday party is coming up on December 16, 2023 and the Board is invited to attend both of these events.

• Department Reports:

Department reports were included in the packet for review. There was no additional discussion on these.

Dean Engle was asked what was included in the Tabletop Gaming for the students and he also gave credit to Rich Rowe for the idea of a Cheer Club for our students. He also stated that his department will go through a little shifting again as the Financial Aid Director submitted resignation and their last day at Dawson Community College is planned to be Friday, December 1.

• Enrollment Management Report:

Dean Engle presented his report to the Board of Trustees. He stated that with job market shifting and the COVID pandemic the College outlook for students has also shifted. Students are struggling more and this has decreased enrollment overall. His report showed graphs to overall compare the different categories of students enrolled. Dean Engle also reviewed the enrollment plan going forward starting Fall 2024 in the

recruitment process. There was discussion going over Apply MT and how it effects our recruitment and enrollment at Dawson Community College.

• Legislative/OCHE/NWCCU Strategy and Review:

President Villmer reported on this. One of the strategies the two-year sector is working on is a funding model for non-credit workforce development trainings. A task force is working on building the strategy with OCHE to request funds for short-term credit trainings. President Villmer serves on this taskforce. Businesses want trained people to be able to enter the workforce very quickly, and we are going to work towards making this happen. One of the largest challenges we are facing is that there is little to no funding for these types of non-credit trainings.

Finance Committee

Meeting minutes are included in the board packet for the November 14, 2023 meeting. Trustee Thorson went over the minutes and for this meeting. The meeting included an update on the Audit for FY2022 and where Wipfli is in the process of completion. The Employee Retention Credit was discussed and will be looked into further as President Villmer plans to reengage with Sheridan Wealth. The Tuition, Fees, Housing and Meal plan is planned to be presented at the December Finance Committee meeting.

A copy of the voucher lists were included in the board packet for review.

HR Committee

No meeting took place in November for the Human Resource Committee.

A copy of the Human Resource Committee report was included in the board packet for review. There was also an updated one hand delivered to the Board of Trustee meeting.

Policy Committee
