Meal Plan Options (Semester Cost):**

**All students residing in campus housing are required to purchase a meal plan. If no option is made, students are assigned the least expensive option. Students have the ability to add funds to meal accounts if needed.

Full Pell Grant for the 2023-2024 school year is \$7,495. Amount awarded depends on financial need and cost of attendance.

- **GEM - Growing Eastern Montana (GEM)** tuition rate applies to students who are residents of North Dakota, South Dakota, and Wyoming and is equivalent to the in-state rate.
- **WUE - Under the Western Undergraduate Exchange (WUE)** program, students enroll in out of state college at a reduced tuition level. Residents from the following states may participate if eligible: Alaska, Arizona, California, Colorado, Hawaii, Idaho, Nevada, New Mexico, Oregon, Utah, and Washington. Residents from the following Commonwealth of Northern Marianas Islands may participate if eligible: American Samoa, Northern Marianas, Guam Marshall Islands, and the Federated States of Micronesia and Palau.
- **CANADIAN EXCHANGE - Under the Canadian Exchange** Program, residents from the following provinces may participate, if eligible: Alberta, British Columbia, Manitoba, and Saskatchewan.
