
PARAEDUCATOR ASSURANCES

- ___ **Initial** to verify that you have worked or will have worked as a Paraeducator for at least 1,000 hours before your anticipated start term.
- ___ **Initial** to verify that you understand that in exchange for tuition payments on your behalf, this program will require a contract that includes a one-year service payback at a Montana public school working with students with disabilities in the year after the Dawson courses have been completed.
- ___ **Initial** to verify that should your employment status change and you are no longer eligible to receive tuition payments, you will notify the OPI and Dawson Community College immediately.
